NOTIFICATION

Subject : Revision of rates of TA/DA etc. for project related staff.

In supersession of all previous notifications on this issue and as per decision of the Committee constituted for the above purpose, it is hereby notified that the rate of TA/DA for Research Associates and other research related staff has been revised as under :

A. Other than Project Scholar(Science, Arts & Commerce).

1. For Non-NET Ph.D Scholar getting full time scholarship will be paid the following :

- i) **TA (beyond State)** – From Agartala and upto destination by train in Second class (slipper)/ Bus of State Transport or ordinary bus service and Auto fare where train connection is not available **subject to production of Bill/Voucher and availability of fund in the contingency head of the concerned Scholar.**
- ii) **Food bill** : Rs. 250/- (beyond State) Rs. 180/- (inside the State for field work etc.) per day **subject to production of certified bill/voucher and also availability of fund in the contingency head of the concerned Scholar.**
- iii) **Accommodation Charges** : Beyond the State only Rs. 300/- per day (Maximum) on production of actual voucher.
- iv) **Registration fee** : Actual. (Maximum limit of Registration fee including TA & Food bill & Accommodation charges will be limited at Rs. 6,000/).

However, these facilities be extended only on completion of 2(two) years of Research work and on the recommendation of the P.R. Review Committee constituted by the Hon'ble Vice Chancellor.

B. Scholar working in the Project (Science, Arts & Commerce).

1. For Research Associate/SRF/JRF/Inspire Fellow will be paid the following :

- i) **TA** (beyond State) – From Agartala and upto destination by train in 3 tier (AC- slipper)/ Bus of State Transport(AC) or ordinary bus service(AC) and Auto fare where train connection is not available subject to production of certified Bill/Voucher and availability of fund in the concerned Project.

The above staff may travel air only on special circumstances for carrying research samples to other Laboratory, as recommended by the concerned P.I/Coordinator subject to availability of fund in the concerned project.

- ii) **Food bill:** Rs. 250/ (beyond State)Rs. 180/- (inside the State for field work etc.) per day subject to production of certified bill/voucher and also availability of fund in the concerned project.
- iii) **Accommodation charges :** In addition of TA & Food bill Scholars may be allowed accommodation charges for their stay out-side the station for attending seminar/training programme etc, and if accommodation has not provided by the Organizing Committee/ Collaborator organization on the following rates (beyond State only for attending Seminar/ project works etc.) Max. Rs. 300/- per day subject to **production of certified bill/vouchers countersigned by the concerned P I /Coordinator** and also subject to availability of fund under the concerned project.

However maximum duration of stay will be limited for 20 days at a time.

- iv) **Registration fee :** Actual subject to availability of fund under the Project head.

C. Other staff working in the Project (Science, Arts & Commerce).

1. For Research Assistant/ Field Assistant will be paid the following :

- i)TA (beyond State) – From Agartala and upto destination by train in 3 tier (slipper)/ Bus of State Transport or ordinary bus service and Auto fare where train connection is not available subject to production of certified Bill/Voucher and availability of fund in the concerned Project.

The above staff may travel air only on special circumstances for carrying research sample to other Laboratory as recommended by the concerned P.I/Coordinator subject to availability of fund in the concerned project.

- ii)**Food bill** (beyond State) Rs. 250/ (inside the State for field work etc.) Rs. 180/- per day subject to production of certified bill/voucher and also availability of fund in the concerned project.

- iii)**Accommodation charges :** In addition of TA & Food bill above project staff may be allowed accommodation charges for their stay out-side the station for any project related works, and if accommodation has not provided by the Collaborator organization on the following rates Max. Rs. 300/-(beyond State) **subject to production of certified bill/vouchers countersigned by the concerned P I /Coordinator** and also subject to availability of fund under the concerned project.
