The bidder should have been in existence for not less than 3 (three) years in similar nature of work (Documentary evidence required to be submitted along with tender proposal).
 - B. The bidder should have an Annual average turnover not below 20,00,000.00 (Rupees Twenty Lakhs) for last three years. Financial Statement duly certified by Chartered firm for last three years be submitted along with the tender.
