1. **Scope of Work:** Scope of work covered under this includes supply, transportation and installation at the Department of Molecular Biology & Bioinformatic, Tripura University Suryamaninagar;
2. **Qualifying requirements:** The bidder must either be a manufacturer or authorised dealer having credential of supplying and installation of above-mentioned items.
3. **An amount Rs. 500.00 (non-refundable cost of tender fee) non-refundable**, shall be paid through **RTGS/NEFT**. A **scanned copy of the payment proof** must be uploaded along with the tender documents. The **bank details** are as under:

5. **Warranty:** Instrument must have minimum 01-year standard warranty.
