CONCEPT NOTE

Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP) is a campaign-public welfare scheme of Government of India. It was launched by the Department of Pharmaceuticals to provide quality medicines at affordable prices to the masses through small counters within and outside government hospitals and CHCs known as Pradhan Mantri Bhartiya Janaushadhi Pariyojana Kendra (PMBJK). This scheme's centres have been set up to provide generic drugs, which are available at lesser prices but are equivalent in quality and efficacy as expensive branded drugs.

Community health refers to the health status, behaviors, and well-being of a specific group of people living in a particular geographic area or sharing common characteristics, such as cultural, social, or economic factors. It focuses on promoting and maintaining the health of the entire community by addressing the collective health needs and concerns of its members.

Low-cost medicine is an important pillar for maintaining the sound public health status, particularly in a developing country like India. The social needs of low-cost medicine in developing countries are significant and multifaceted in terms of its accessibility, affordability, disease control and public health issues. Addressing the social needs of low-cost medicine requires a comprehensive approach involving collaboration among governments, healthcare providers, international organizations, pharmaceutical companies, and NGOs. Together, they can work towards developing sustainable strategies that prioritize affordability, accessibility, and the overall well-being of populations in developing countries.

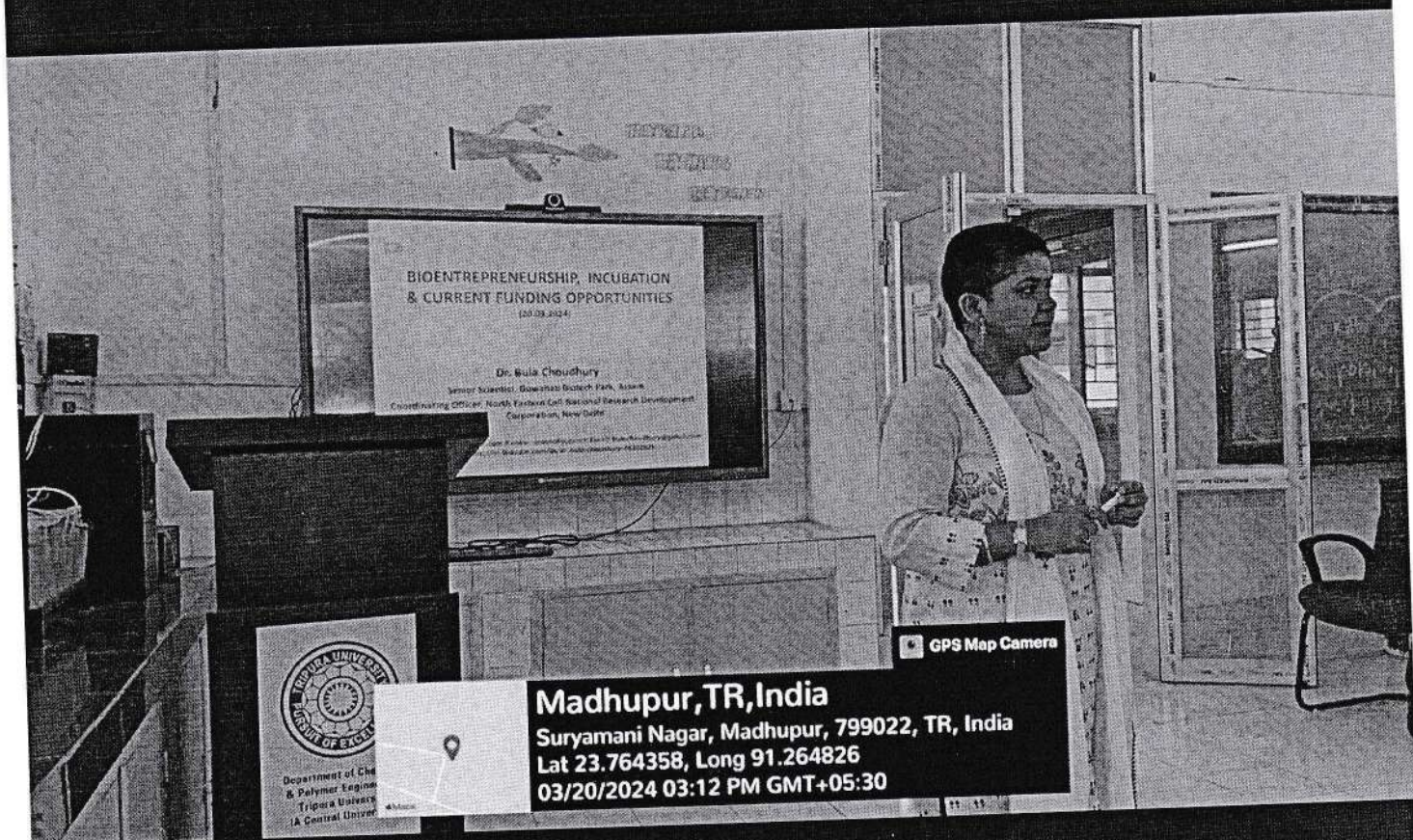

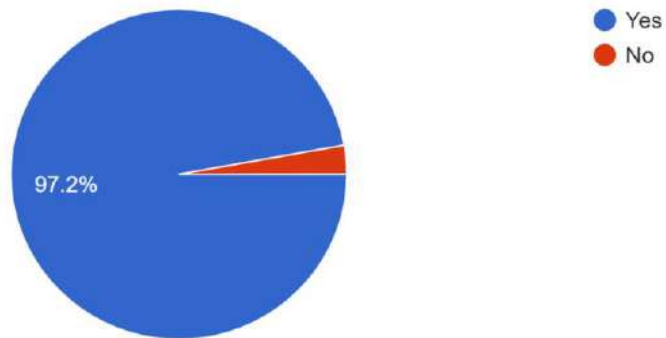

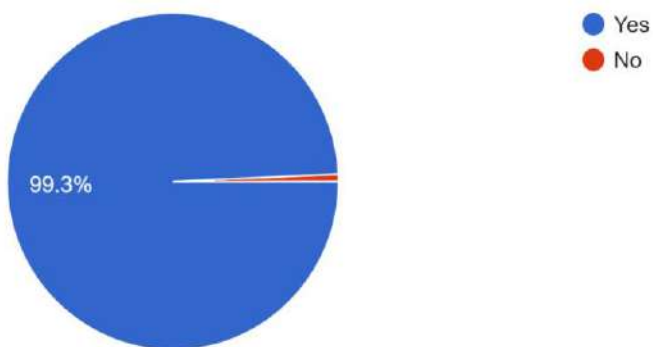
Do you feel we should have more such programme?

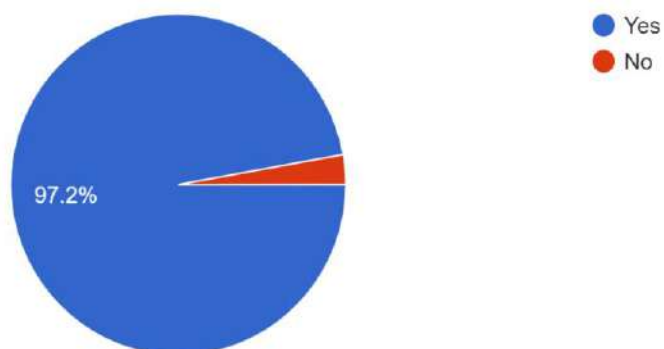
Was the programme educative?

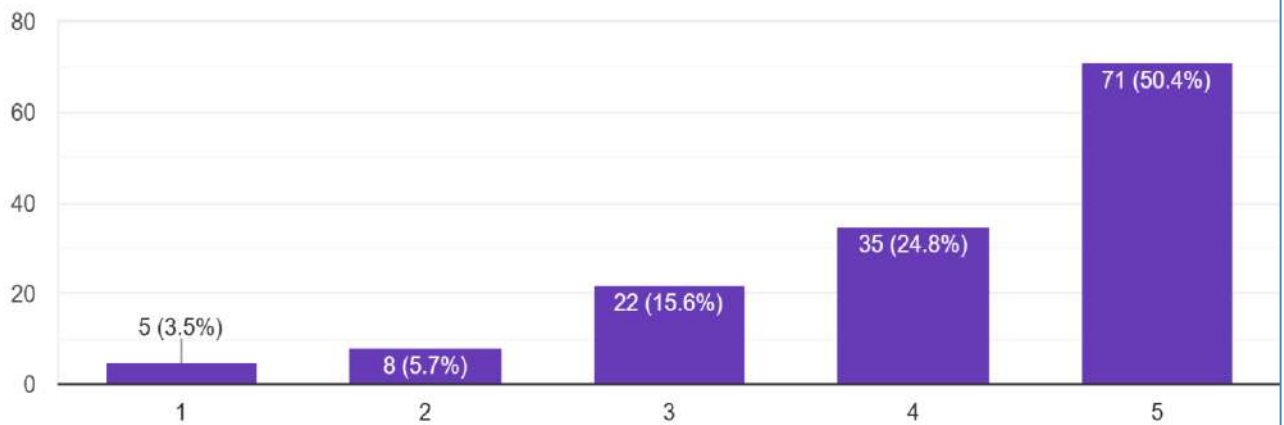

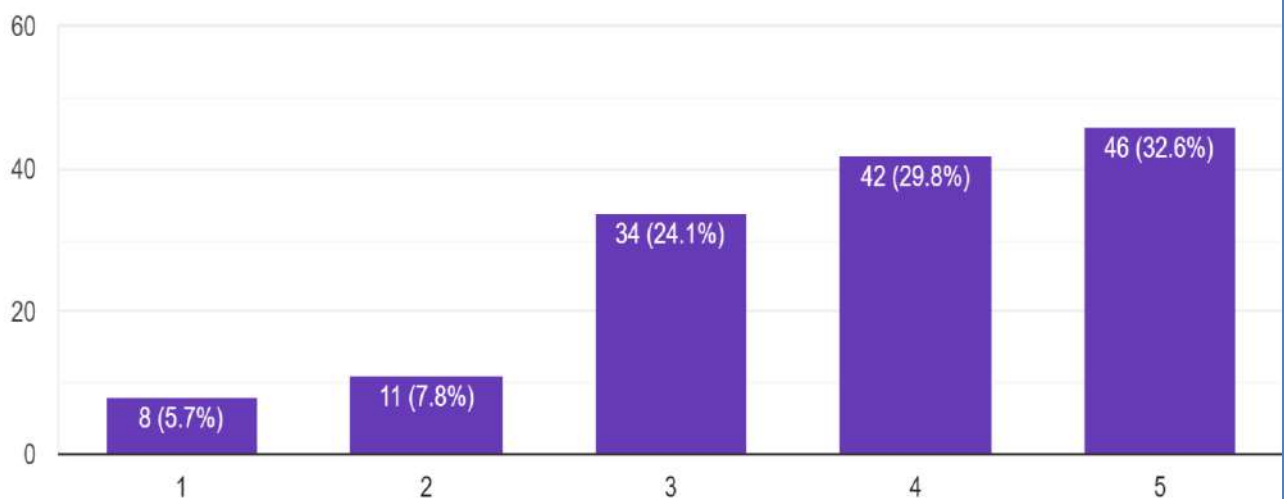

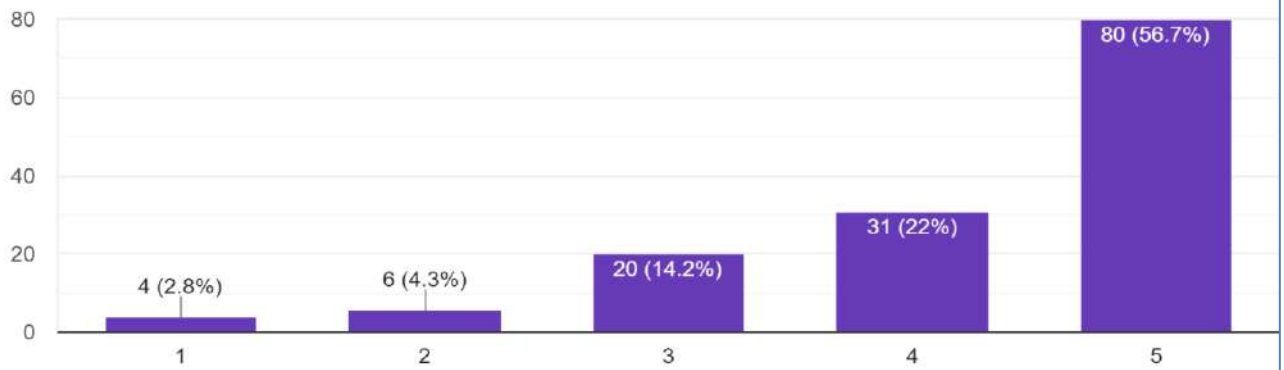

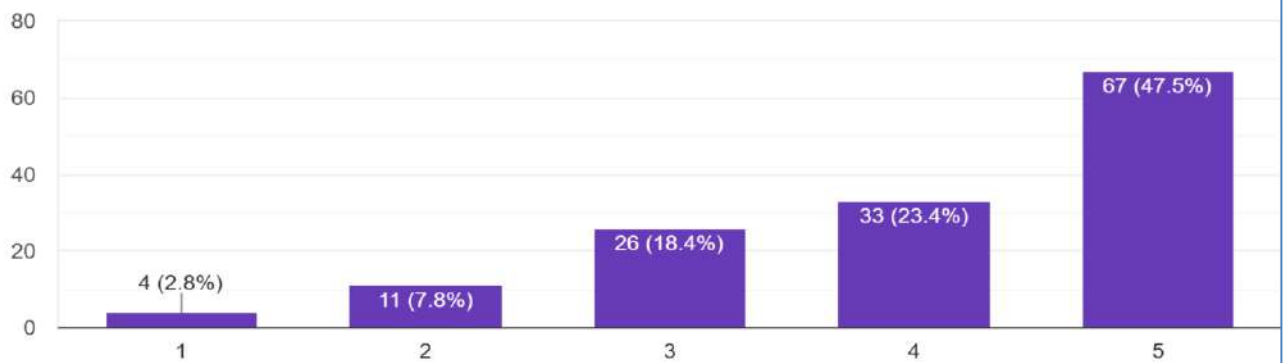

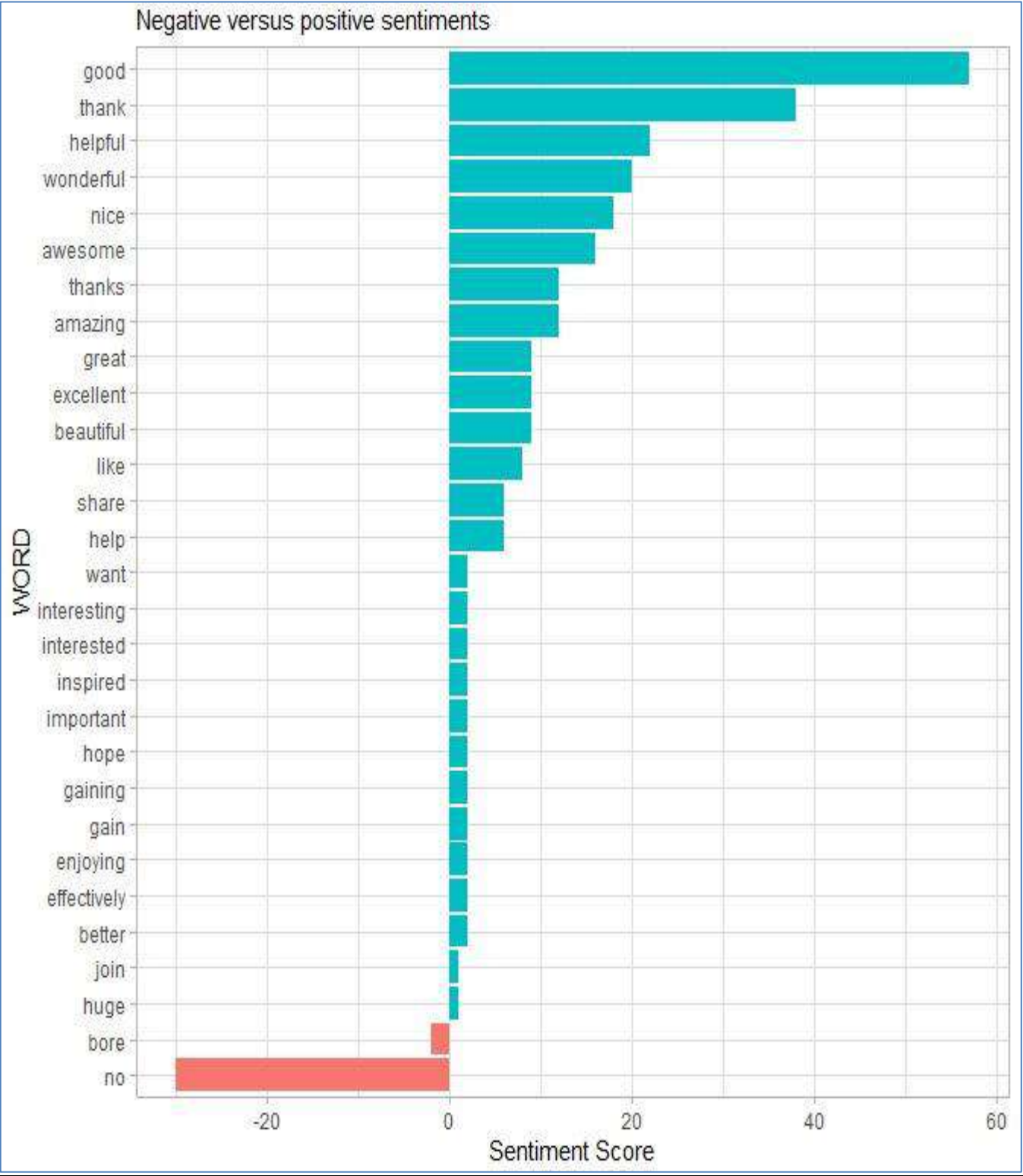


Textual analysis of the sentiments received from the participants (141) who have submitted the feedback after the program.
