To consider the request received from some employees of Tripura University for allowing their candidature having relevant experience from a private institutions(s) with a turnover of less than Rs. 200/- crore, with reference to the Tripura University Employment Notification No.F/TU/REG/ADVT/NT/01/2024, dt. 04.10.2024.

Resolution:

It was unanimously decided that the condition of working experience in a private company/bank 'having a minimum annual turnover of at least Rs. 200 crores or more' be waived off for those applicants who are permanent residents (with a valid documentary evidence) of any state of North-East India subject to endorsement by the Ministry of Education, Govt. of India/UGC, New Delhi.
