Furthermore, in the interest of fairness and transparency in the enquiry process, Sri Krishna Das shall be restricted from entering the Tripura University campus, Suryamaninagar, during the suspension period, to prevent any potential tampering with documents or evidence.

Registrar, Tripura University is authorised to constitute a Preliminary Enquiry (PE) Committee and Board of Inquiry (BoI), i.e. Inquiry Authority as per CCS (CCA) Rules, 1965. Based on Preliminary Enquiry (PE), he is advised to present the fact finding report before the Executive Council within a period of 3 (three) months, relating to matter in agenda No.07/45/25 and other overall process and procedural lapses, during the tenure of Sri Krishna Das.

Sri Krishna Das shall comply with all instructions issued by the Competent Authority during the suspension period.

He is presently in a state of depression and mental trauma and taking treatment.

In view of the matter discussed, it was unanimously resolved that:

- 1) A written statement (along with documentary proof) be obtained from Mr. Lalit Prasain regarding his resignation.
- 2) The said statement and accompanying documents be placed before the Executive Council in its next meeting for further deliberations and a final decision on the matter of Mr. Lalit Prasain's resignation.

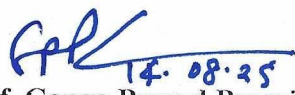
Resolution: **Approved.**
