To approve the Tripura University Cadre Recruitment Rules (Non-teaching Employees), 2021.

At the outset, Professor Ganga Prasad Prasain, Hon'ble Vice-Chancellor and Ex-officio Chairman, Executive Council, Tripura University welcomed all the members of the Council. He extended his heartiest greetings to Professor N. Lokendra Singh for his

appointment as the Vice-Chancellor of Manipur University, Imphal; and also to Professor Khemsingh Daheriya on his joining as Vice-Chancellor in the Atal Bihari Vajpayee Hindi University, Bhopal.

Then, the agenda of the meeting was discussed.

Resolution:

After threadbare discussion, the Tripura University Cadre Recruitment Rules (CRR) for non-teaching employees were approved unanimously with following modifications/amendments:

- 1. The proposal of the Committee constituted to look into the objection/comments of Non-teaching Employees on the Draft Cadre Recruitment Rules (Nonteaching Employees), vide its meeting held on 9th August, 2021 for relaxation in experience for direct recruitment to Section Officer from Assistant (3 years) and UDC (5 years) grades was not considered favourably. It was decided to follow **UGC** Guidelines.
- 2. For promotion to the post of Assistant Registrar from the post of Section Officer, the eligibility criteria would be:
- (i) Five (5) years experience as Section Officer
- (ii) Seniority-cum-fitness test
- (iii) A minimum of 7.5 in APAR Scale
- 3. The composition of Selection Committee to recommend the selection of candidates for the Group-A, B and C posts would be restructured as follows:
- Registrar shall be the 'Member' in the composition of the Selection (i) Committee for Direct Recruitment of Group-A (Non-teaching) posts.
- For recommendation of direct recruitment and promotion of all Group B (ii) & C (Non-teaching) posts, Registrar shall be the Chairperson of the Screening and Selection Committee. Further, Clause 2 & 5 of the Appendix-I(c) and Clause 2 of Appendix-II (b) of Cadre Recruitment Rules (non-teaching Employees) be deleted.

Members resolved that the above modifications/amendments be included in the CRR and revised copy be sent to the Ministry of Education, Govt. of India and the UGC.

The meeting ended with a vote of thanks to the Chair.
