An advertisement No F.TU/REG/ADVT/NT/01/2023 dated 10.11.2023 was issued for several Group-A positions in Tripura University. As per a circular F.No. Misc14017/15/2015-Estt. (RR) dated 11.01.2016 issued by the DoPT, recruitment process may be completed within six months (extendable by another six months). While every effort was made to complete the recruitment process within six

months (plus another six months), but the same could not be fully completed. Out of 9 positions, 5 have been done. In an online meeting with the Additional Secretary, it was suggested that the matter concerning validity may be discussed in the Executive Council for discussion and decision.

Resolution: All the members unanimously resolved to extend the process for recruitment of Assistant Registrar for another period of six months.
