The Registrar, Tripura University briefed that the Written Test for various Non-teaching Group-C posts were conducted on 15th & 16th February, 2025 following the strict security measures with a view to ensure fairness. The evaluation of answer scripts was completed. But results for few Group-C posts could not be published due to some legal issues.

Resolution: After threadbare discussion, it was resolved to take appropriate action as per the legal opinion of the Standing Counsel of Tripura University.
